I. COLLECTION OF INFORMATION

Information you provide directly to us. We collect information you provide directly, including:

<u>Information we collect automatically</u>. By using the Site, you consent to our use of cookies and similar technologies.

When you contact us, we may monitor or record your call for quality assurance, training and security purposes.

<u>Information we obtain from other sources</u>. We may receive information about you from other sources, including through companies that collect consumer information such as demographic and interest data. In addition, if you access third-party services, such as Facebook, Google, or Twitter, through the Site or to share information about your experience on the Site or with our Services with others, we may collect information from these third-party services.

II. USE OF INFORMATION

We generally use the information we collect to:

- Fulfill your requests for products, services, information and support;
